



**ADMISSION OF STUDENTS
AT THE FACULTY OF VETERINARY MEDICINE – IN ENGLISH
IN THE ACADEMIC YEAR 2014-2015**

Romanian citizens, citizens from EU/SEE/CE countries or citizens from non – EU countries can be accepted for studies at the **Faculty of Veterinary Medicine in Iasi – study in English** according to the *Methodology of admitting foreign citizens for studies in the academic year 2014/2015*.

ADMISSION CRITERIA:

- **Certificate proving English language competencies – at least B1 level** (*Internationally recognized certificates are accepted*). Students from countries where English is the official state language do not need such a certificate.
- **The Baccalaureate grades average.**

PLACES AVAILABLE: 50

ADMISSION PERIOD:

- Candidates must send their files at the USAMV Iasi until **September 10th**
-
- **Admission and English proficiency test – September 22nd – 25th**. Candidates must come **personally** at the USAMV Iasi.

FEES:

- The file processing fee - **50 €** (non-reimbursable)
- The tuition fee is **4500 Euro** / academic year.

ADMISSION PROCEDURES

- I. **Romanian citizens** may choose to study **Veterinary Medicine in English** under the same conditions applicable to candidates from EU-third countries members states, EU members states, the European Economic Area and the Swiss Confederation, including the tuition fees.

The application file should contain the following documents:

- a. Application form
- b. The **Baccalaureate diploma** or an equivalent – original/ legalized copy;
- c. **The transcript of records** for the latest high-school education cycle and **the results of the baccalaureate examination** - original/ legalized copy ;
- d. **Birth certificate** – legalized copy);
- e. **Marriage certificate** (if the name changed after marriage) – legalized copy);
- f. Copy of valid Identity card;

- g. **Medical certificate** to prove that the person to be registered for studies does not suffer from infectious diseases or other illnesses that are incompatible with the future profession;
- h. **Certificate proving English language competencies – at least level B1** (Internationally recognized certificates are accepted).
- i. **Receipt** for the file processing fee – see section 2
- j. **4 passport-size photos.**

II. EU / SEE / CE citizens

Conditions for eligibility:

- Certificate proving English language competencies – at least Level B1 ([Internationally recognized certificates are accepted](#)). Students from countries where English is the official state language do not need such a certificate.
- All the study documents must be issued by education institutions acknowledged in the country of origin and **recognized by the Romanian Ministry of National Education – National Centre for Recognition and Equivalence of Diplomas in Romania (CNRED)**

After CNRED analyses the study documents, a certificate from CNRED is issued, which has to be submitted together with all the required documents for admission to USAMV Iasi.

1. *The application file should contain the following documents:*

- a. **Certificate for recognition of studies from CNRED;**
- b. **Application form**
- c. The **Baccalaureate diploma** or an equivalent – original copy and legalized translation;
- d. **The transcript of records** for the latest high-school education cycle and **the results of the baccalaureate examination** – original copy and legalized translation (if the original is in a language other than English or French);
- e. **Birth certificate** – original copy and legalized translation (if the original is in a language other than English or French);
- f. **Marriage certificate** (if the name changed after marriage) original copy and legalized translation (if the original is in a language other than English or French);
- g. Copy of valid **passport** pages 1,2,3,4 or an official valid ID;
- h. **Medical certificate** to prove that the person to be registered for studies does not suffer from infectious diseases or other illnesses that are incompatible with the future profession;
- i. **Certificate proving English language competencies – at least level B1** ([Internationally recognized certificates are accepted](#)). Students from countries where English is the official state language do not need such a certificate.
- j. **Receipt** for the file processing fee – see section 2
- k. **4 passport-size photos.**

Notes:

- Documents in languages other than English or French must be accompanied by a certified translation in Romanian;

- Diplomas of applicants from Italy, Greece, Spain, Portugal and Cyprus should bear the Hague Convention Apostil;
- Diplomas issued in countries which are not part to the Hague Convention must be legalized by the Ministry of Education and the Ministry of Foreign Affairs of the issuing country and the Embassy of Romania in that country.

3. The deadline for files submission at the University is September 10th 2014. Applications will **NOT** be received after this date.

I. Non-EU citizens

Conditions for eligibility:

- Certificate proving English language competencies – at least level B1 ([Internationally recognized certificates are accepted](#)). Students from countries where English is the official state language do not need such a certificate.
- Study documents issued by education institutions acknowledged in the country of origin and **recognized by the Romanian Ministry of National Education**.

Applications will NOT be received after this date.

1. *The application file should contain the following documents (in two copies):*

- Application** for the Letter of acceptance to studies ([click to open](#)). The form needs to be filled out completely in two copies and 2 photos;
- Application form**
- The Baccalaureate diploma** or an equivalent – original copy and legalized translation (translated if the original is in a language other than English or French);
- The transcript of records** for the latest high-school education cycle and **the results for the baccalaureate examination** – original copy and legalized translation (if the original is in a language other than English or French);
- Birth certificate** – original copy and legalized translation (if the original is in a language other than English or French);
- Marriage certificate** - if the applicant's name changed after marriage;

- g. **Copy of passport** pages 1, 2, 3, 4 or an official ID valid at least 6 months after the date when the letter of acceptance is issued;
- h. **Medical certificate** specifying that the candidate does not have any contagious diseases or any other diseases incompatible with the profession and proving the applicant's health;
- i. **Certificate proving English language competencies – at least level B1** ([Internationally recognized certificates are accepted](#)). Students from countries where English is the official state language do not need such a certificate.
- j. **Receipt** for the file processing fee – see section 2

Note:

- Documents in languages other than English or French must be accompanied by a certified translation in Romanian;
- Documents belonging to applicants from non-EU countries must first be authenticated by the Romanian Embassy in the applicant's country.

3. The candidates will send their files directly to the where the files are evaluated and the list of the proposed candidates and the study documents are sent to the Ministry of National Education – General Direction for International Relations. The General Direction for International Relations will issue the Letter of acceptance for studies and will send it to the University.

4. Candidates from non-EU countries must obtain the study visa from the Romanian Embassy in the country of origin which is granted based on the Letter of Acceptance issued by The General Direction for International Relations of the Romanian Ministry of National Education.

Admission of the candidates from EU-third countries will be done within the limit of available places. The ranking of the candidates is based on their average scores for **the baccalaureate examination**.

ENROLMENT PROCEDURE

The candidates that have been officially admitted will confirm in writing, within **3 working days**, their registration decision and the tuition fee will be paid in accordance with **GOVERNMENT ORDINANCE NO. 22/august 2009**, approved by law No. 18 in January 2010 and **Decision of the University Senate No. 24/28.05.2014**. Otherwise, the University considers the candidate as rejected.
